How the Scholarship is Awarded

The Scholarship will cover resident tuition and fees for up to 12 hours for the top 10% of Mt. Pleasant and Chapel Hill graduating classes. Remaining students will receive resident tuition for up to 12 hours. Those students will be required to pay fees. Students requiring assistance to pay fees at the time of registration should check with the Business Office at NTCC for financing options.

Example based on Spring 2019 tuition and fees: Total resident tuition and fees for a student taking 12 hours is \$1,157.00. If student is not in the top 10%, scholarship would pay resident tuition costs of \$492.00; student would pay \$665.00 for fees.

Scholarship Guidelines

1. Student must complete the **Free Application for Federal Student Aid (FAFSA)**.
2. Student must write a one page thank you letter addressed to **Members of the Mt. Pleasant Community Fund**. Please include in the thank you letter what this scholarship will mean to you.
3. Student must be a 2019 graduate of Mt. Pleasant or Chapel Hill High School.
4. Student must attend Northeast Texas Community College in the Fall semester 2019 and consecutive semesters thereafter.
5. Student must be enrolled in a minimum of 6 semester hours. The maximum hours covered by the scholarship per semester is 12.
6. Scholarship ends after two consecutive years.

Students eligible for Federal Student Aid will not be eligible for this scholarship unless the grant does not cover the total cost of resident tuition for (up to 12 hours) or resident tuition and fees (up to 12 hours) for the top 10% of the class. The balance will be paid by the scholarship.

Scholarship is for Fall and Spring semesters only and is subject to change on a yearly basis.

Maintain a 2.0 cumulative GPA during the first 30 hours completed
Maintain a 2.5 cumulative GPA for hours above 30
