ABOUT THE NTCC SIMULATION LAB

Our Simulation Lab is a resource available to PCT/ Assistant students to facilitate real patient situations in a life-like setting. We are committed to advancing safe, high quality effective patient care in all Health Science programs by integrating cuttingedge simulation technologies into the training of our learners.

The facility consists of a hospital room, a control room and a lab for training. The hospital room and lab simulate hospital settings and are equipped with beds, headwalls and medical equipment. A Virtual Reality station for anatomy and virtual patent care is also housed in the large room.

The Simulation Lab currently has eight high fidelity simulators. This includes a birthing simulator, four full size adult patient simulators and three pediatric simulators. All have advanced clinical functionality such as voice, breath, heart and bowel sounds. The vital signs of the patient simulators can be programmed and respond to learner actions.

JOB OUTLOOK

Texas has one of the highest CNA employment rates, according to the U.S. Bureau of Labor Statistics. There are more than 88,000 CNAs currently employed. Texas is also ranked top in the nation for CNA wages with Tyler, Texas being the 5th top-paying metro area in the country at nearly \$19/hour. CNAs can make \$50,000 annually, and nursing assistant jobs are relatively easy to find.

Overall employment of Patient Care Technicians/Assistants is projected to grow 8 percent from 2020 to 2030, about as fast as the average for all occupations.

Patient Care Technicians/Assistants work as part of a healthcare team under the supervision of licensed practical or licensed vocational nurses and registered nurses.
