Course Description: 1 credit hour. Three hours of lab each week. This laboratory-based course accompanies PHYS 1303, Stars & Galaxies. Laboratory activities will reinforce the study of the Sun and other bodies in our solar system, including the origin of our solar system. This course will not satisfy a core curriculum requirement, buy may satisfy a degree requirement.

Prerequisite(s): None.

Student Learning Outcomes:

Upon successful completion of this course, students will be able to demonstrate understanding of qualitative concepts relating to the following learning outcomes:

- 1103.1) Recognize scientific and quantitative methods and the differences between these approaches and other methods of inquiry used in modern astrophysics.

 1103.3) Use basic laws of astronomy to solve assigned tasks.
- 1103.4) The ability to translate, interpret, and extrapolate scientific theory governing the formation and motion of stars.
- 1103.5) The ability to translate, interpret, and extrapolate scientific theory governing the formation and evolution of galaxies and the universe.

Evaluation/Grading Policy: All lab assignments have equal weight. The final grade will be assigned by the average of all lab assignments according to the following letter scale. There will not be any major test.
