# This syllabus serves as the documentation for all course policies and requirements, assignments, and instructor/student responsibilities.

Course Description: This course studies minority-majority group relations, addressing their historical, cultural, social, economic, and institutional development in the United States. Both sociological and social psychological levels of analysis will be employed to discuss issues including experiences of minority groups within the context of their cultural heritage and tradition, as well as that of the dominant culture. Core concepts to be examined include (but are not limited to) social inequality, dominance/subordination, prejudice, and discrimination. Particular minority groups discussed may include those based on poverty, race/ethnicity, gender, sexual orientation, age, disability, or religion. Three credit hour course.

Prerequisite(s): None

Student Learning Outcomes: Explain how the concept of social inequality pertains to minority group status defined in terms of identities that may include: social class, race/ethnicity, gender, sexual orientation, age, disability, or religion.

Differentiate between important concepts and theories of prejudice and discrimination including the effects of prejudice and discrimination on the everyday lives of minority group members in the context of social institutions.

Analyze the history of culture, experiences of inequality, and current life opportunities of various minority groups in the United States with contrasting reference to other countries.

Analyze minority group interactions in the United States focusing on immigration and migration patterns, assimilation processes, and adjustments to American life.

#### **Course Structure and Overview:**

This is an ONLINE class which means all instruction is done online via the learning management system BLACKBOARD Students are expected to complete all the readings of the required e-book chapters, watch the instructional videos and complete the online chapter activities. You will see that the course is divided into 10 weeks in the Blackboard portion. Each week you will be expected to complete certain online assignments for the chapters found in that week's folder. This course requires daily computer and internet access. You should expect to spend no less than 3-6 hours a week in this course. Pay close attention to deadlines for all assignments. Assignments will not be accepted late! Technical difficulties are no excuse for late assignments. YOU CANNOT PASS THIS COURSE WITH OUT COMPLETING THE ONLINE PORTION! In class participation is an essential element in this course. Each student will be expected to participate in speaking drills/activities which will occur during class time. These activities will allow students to sharpen their presentations and enhance delivery skills.

There will be two tests (100 points each). Everyone must take the final exam. Exams will consist of multiple-choice, matching or definitions, and short essay questions. # DISCUSSION BOARDS/ATTENDANCE AND PARTICIPATION - Value: 100 pts. Due various dates throughout semester

Each student will participate in the learning process by participating in various discussion boards, classroom discussion and activities. Assigned throughout semester. Discussions/Activities is where we will assess your participation, whether you are an online or face-to-face learner. You are expected to be an active and engaged class member throughout the semester. Discussions/Activities are a way to exchange ideas and learn from your peers. Each student is expected to participate in the discussions/activities fully. It could involve summarizing articles, responding to questions from the text, or viewing and commenting on streaming videos. There will be a minimum of 10 activities worth 10 points each.

### **ONLINE LEARNERS:**

To receive credit, you must post your response to the posted discussion board questions by Thursday at midnight. In addition, you must post a response to another peer's post by Sunday at midnight. Your grade on the discussion board is based on participation. Each discussion board assignment is worth 10 points. However, to receive full credit for these posts, you must fulfill some basic requirements: - After posting your answer to the question, you are expected to respond to a minimum of one other peer in the class. Initial posts should be a minimum of 75 words, and a response at a minimum of 50 words. All posts should be relevant to the topic being discussed but should also attempt to introduce a new point of view or piece of information or otherwise further the discussion. Posts should use correct grammar, punctuation, and vocabulary appropriate for a college-level course. Misuse of the discussion boards will not be accepted.

#### **Assignments:**

All written assignments should be typed (12-point font), double-spaced, with one-inch margins, a title page and stapled. Students are encouraged to submit written work that has been spell-checked and is free of grammatical errors. Students are expected to use APA style when citing reference materials. Students are advised that points will be deducted if these criteria are not met.

#### Reflection Paper - Value 100 pts.

# March 19th

Students will write a 3-4 paper reflecting on minority matters topic selected by student. According to the College Board website, "A reflective essay is an authentic written composition that allows you to explore a topic of importance and reflect upon it. In your reflection, you analyze, synthesize, and evaluate an issue or event in light of your prior knowledge, present experiences, and future goals. You are also expected to evaluate what you understand about the topic at the end of the paper." This assignment will help us understand what topics are essential for upcoming coursework and what could be addressed during papers and other assignments in the class. In addition, we'll learn how to integrate our writing from different classes into a summative document for our class.

What were the practical strategies used to write this paper? Did I effectively analyze the topic and use examples to support my analysis? Did I effectively use transitions between paragraphs and sections in my paper? How well did I craft my introduction and conclusion to transition my readers into my analysis of my topic? Did I effectively engage a variety of writing styles, including expository writing, narrative writing, and argumentative writing? My motivation to write on this topic is the injustice I see in society

every day in the news. Drawing on personal experiences connects the reading experience with the topic. Did I connect the paper to other readings/writings that we have done in this class? Was my conclusion accurate and appropriate to my chosen topic? The instructor can assist with the selected topic, but encourages students to find a topic that they are passionate about or need more knowledge and understanding of said topic.

The "Othering Project" - Value: 100 pts. DUE: March 3<sup>rd</sup>

Research projects are a valuable component of college courses. In this class, a 3-5 page essay paper (double-spaced) on "othering" specifically related to a minority population is required. "Othering,' in this sense, refers to the practice whereby a member of a minority group is treated as an "other/something else" based on his/her/their cultural beliefs and practices or some other attribute. For example, individuals with a disability, particularly visible one, are often stigmatized and treated as something "other" and apart from the "abled" population. Students will select a population for the study, research the concept of "othering," apply it to their selected population and give examples of how "othering" manifests in a specific social institution (e.g. education, health care, social class/economy, religion, family, military, political system/government, or media).

Students may work alone on the essay or in groups of two people (maximum). Students who work in pairs will turn in one essay, and they'll receive the same grade.

#### **Communications:**

Emails will be responded to with 48 hours. If you do not receive a response within 48 hours, then the email was not received. Posts in the Discussion Forum "Questions, Comments, and/or Concerns?" will be monitored by the instructor. Responses by the instructor will be within 72 hours of post. The college's official means of communication is via your campus email address. I will use your campus email address and Blackboard to communicate with you outside of class. Make sure you keep your campus email cleaned out and below the limit so you can receive important messages. In addition, I use the REMIND App to get information out to students quickly. This will enable you to receive important class announcements and reminders from me via text message so that you will not miss out on any assignment changes or important updates. Please continue to check your NTCC email daily. If you do not own a cell phone, you can receive these same reminders through your email... the instructions are also in the PDF.
