Course Description: 2 credit hours

A study of drug classifications, actions, therapeutic uses, adverse effects, routes of administration, and calculation of dosages. HPRS 2200 is a prerequisite for the Vocational Nursing program. This class will be offered with 100% online course delivery.

Prerequisite(s): None

Student Learning Outcomes: Categorize the classification of drugs; calculate drug dosages; and identify the therapeutic use, routes of administration, indications, contraindications, and adverse effects.

Evaluation/Grading Policy:

Students must achieve a grade of "75" (C) to pass this course. There is NO ROUNDING OF GRADES (Ex. 74.99 = 74).

Grades will be assigned based on percentage earned.

Course Structure and Overview: This is an ONLINE class which means class meets online via the learning management system BLACKBOARD. ZOOM recorded lectures will be used in this course. In class meetings may occur throughout the semester, as needed. Students are expected to complete all the readings of the required e-book chapters, watch the instructional videos and complete the online chapter activities.

You will see that the course is divided into 16 weeks in the Blackboard portion. Each week you will be expected to complete certain online assignments for the chapters found in that week's folder. This course requires daily computer and internet access. You should expect to spend no less than 4 hours a week in this course. Pay close attention to deadlines for all assignments. Assignments will not be accepted late! Technical difficulties are no excuse for late assignments. A due date assignment schedule is posted in the START HERE folder in Blackboard the entire semester! Please check it weekly so that you know what

is due and do not miss anything.
