**Course Description:** Instruction in the artistry of hair design. Topics include theory, techniques, and application of hair design.

**Prerequisite(s):** Cosmetology Certificate Program (32 CH in CSME Courses)

**Student Learning Outcomes:** Practice basic competencies related to the artistry of hair design; demonstrate use of tools; exhibit basic manipulative skills; and follow safety and sanitation laws according to the state licensing agency.
