This syllabus documents all course policies and requirements, assignments, and instructor/student responsibilities.

Course Description: The course surveys various theories of crime, with an emphasis on understanding the social causes of criminal behavior. The techniques for measuring crime as a social phenomenon and the characteristics of criminals are examined. This course addresses crime types (such as consensual or white-collar crimes), the criminal justice system, and other social responses to crime. Three credit hours.

Prerequisite(s): None

1. Identify major criminological theories.
2. Define key concepts associated with criminology.
3. Describe the major categories of crime.
4. Describe the components and explain the dynamics of the criminal justice system.
5. Explain the various methodological approaches used to research crime and criminal behavior.

Grading and evaluation--Generally, a “ C “ course grade represents an acceptable level of work. A course grade of "B" represents a substantial effort and achievement. If you go to Windows Accessories, you will find Internet Explorer still on your computer, but it is not your default browser. Course Structure and Overview:

Course Structure and Overview: This is a sixteen-week online course where students must access graded activities on the Blackboard Learning Management System. A typical class involves general participation by all members in discussions. Students must complete online homework, discussion forums, assignments, and exams. Students must watch instructional videos, read course textbooks, and complete online assignments in the Learning Management System, Blackboard, by due dates.

Assignments:

All written assignments should be typed (12-point font), double-spaced, with one-inch margins, a title page, and stapled. Students are encouraged to submit written work that has been spell-checked and is free of grammatical errors. Students are expected to use APA style when citing reference materials. Please refer to the APA manual or use www.apastyle.org for guidelines on writing in APA format. Students are advised that points will be deducted if these criteria are NOT met.

THEORY PAPER (SLO 1& CT2) 100 POINTS

This assignment aims to deepen your understanding of major criminological theories by identifying and analyzing them in the context of real-world crimes. You will explore the reasons why crime exists through various theoretical lenses, considering factors such as social, psychological, and biological influences. By applying these theories to specific examples of criminal behavior, you will not only illustrate the practical application of these concepts but also develop critical thinking skills that allow you to evaluate the effectiveness of different theories in explaining crime. The paper should be written in APA format, with proper citations and references, and should be 3-4 pages in length, excluding the cover page and reference page.

DISCUSSIONS (SLO 1, & SLO 3) 100 POINTS 5 DISCUSSIONS – 20 POINTS EACH

Discussions are a crucial part of your participation in both online and face-to-face learning environments. They are designed to ensure you remain an active and engaged member of the class throughout the semester. These discussions and activities provide a platform to exchange ideas, learn from your peers, and deepen your understanding of the course material.

Each student is expected to fully participate in all discussions and activities. This may involve summarizing articles, responding to questions from the text, or viewing and commenting on streaming videos. There will be

at least five discussions, each worth 20 points.

POSTING DISCUSSIONS

To receive credit for each discussion, you must; **Initial Post:** Post your answer to the discussion board question by Thursday at midnight. Your initial post should be at least 100 words. **Response Post:** Respond to at least one peer's post by the proceeding Monday at midnight. Your response should be at least 75 words. Students are required to provide citation sources.

GRADING CITERIA

Your grade on the discussion board is based on your participation. Each discussion board assignment is worth 20 points. To receive full credit, your posts must meet the following requirements:

Relevance: All posts should be directly related to the topic being discussed. They should contribute to the conversation by introducing a new point of view, providing additional information, or otherwise furthering the discussion.

Engagement: After posting your answer, you are required to respond to at least one other peer in the class. Engaging with your classmates helps create a dynamic and interactive learning environment.

Quality of Writing: Posts should use correct grammar, punctuation, and vocabulary appropriate for a college-level course. Ensure your writing is clear, concise, and free from errors.

Respectful Communication: All interactions on the discussion boards should be respectful and constructive. Misuse of the discussion boards, including inappropriate or disrespectful comments, will not be accepted.

DATA WORKSHOPS (SLO 2)

100 POINTS

4 WORKSHOPS – 25 POINTS EACH

Sociology data workshops are highly informative and engaging activities designed to equip students with the skills and knowledge to analyze and interpret sociological data effectively. These workshops are integral to fostering a deep understanding of sociological concepts and methods. They provide students with hands-on experience, allowing students to apply their knowledge and skills through practical exercises and real-world scenarios. There will be at least four workshops throughout the course, each worth 25 points. Data Workshops must be written in APA format and include a minimum of 150 words. Workshops will include practical exercises, data analysis, and reflective questions to ensure comprehensive learning.

EXAMS (TEST) (SLO 3 & CT1)

100 POINTS PER EXAM

There will be two tests (100 points each). Everyone must take the exams. Exams will include multiple-choice, matching or definitions, and short essay questions. As a rule, make-up examinations will not be permitted unless the student's absence is excused in advance. A grade of incomplete ("X") will not be given unless the student contacts the instructor to make special arrangements for making up the required work. Only an emergency that prohibits the student from completing the course as planned will warrant consideration of the grade of "X". **EXAMS on released on the date above and students are provided 48 hours to complete the exam.**

Communications:

The college's official means of communication is via your campus email address. Emails will be responded to within 48 hours (about 2 days). I will use your campus email address, Microsoft Teams, and Blackboard to communicate with you outside class. Ensure you keep your campus email cleaned out and below the limit so you can receive important messages. The preferred communication method is **Microsoft TEAMS** will improve communication between students and instructors.

All students are strongly encouraged to download the Microsoft team's app on their personal phones or computer. This will be my primary communication tool for this course. To download the Teams mobile app, go to your mobile device's IOS App Store or Google Play Store and download the app. Once downloaded, use your NTCC email and password to log in.
