## Course Syllabus

**Course Description:** A survey of the social, political, economic, cultural, and intellectual history of the United States from the pre-Columbian era to the Civil War/Reconstruction period. United States History I includes the study of pre-Columbian, colonial, revolutionary, early national, slavery and sectionalism, and the Civil War era. Themes that may be addressed in United States History I include: American settlement and diversity, American culture, religion, civil and human rights, technological change, economic change, immigration and migration, and creation of the federal government.

1. Create an argument through the use of historical evidence.
2. Analyze and interpret primary and secondary sources.
3. Analyze the effects of historical, social, political, economic, cultural, and global forces on this period of United States history.

**Required Computer Literacy Skills:** Ability to use Blackboard as well as Microsoft Office. Microsoft Office programs, including Word, are provided free to all enrolled students.

#### **Course Structure and Overview:**

##### ***MidTerm Exam:***

MidTerm examination will cover material from the first half of the course.

##### ***Final Exam:***

The Final Exam will focus on material covered in the second half of the course but will also include some comprehensive questions.

##### ***History Research Project:***

Students will conduct research and write an essay on a topic related to the course. As part of this process, students will complete several preparation assignments including submitting AI brainstorming ideas, an annotated bibliography, thesis statement and topic sentences, as well as first draft for self review.

##### ***Connect Assignments:***

Online activities through Connect are auto-graded. These include chapter reading, map activities, and podcasts. Point values are weighted so keep in mind that some activities are worth more points than others. These activities are intended to help prepare you for the MidTerm and Final Exams.

##### ***Discussion Based Assignments:***

These assignments involve writing and are manually graded involving a rubric. These activities allow you to be creative as well as develop critical thinking skills.

**Communications:** Blackboard messages or direct email serve as the best ways to communicate. \*Reminder: NTCC email is the official form of communication used by the college. TEAMS is the only other official form of communication.

In essence, a parent has no legal right to obtain information concerning the child's college records without the written consent of the student. In compliance with FERPA, information classified as "directory information" may be released to the general public without the written consent of the student unless the student makes a request in writing. Directory information is defined as: the student's name, permanent address and/or local address, telephone listing, dates of attendance, most recent previous education institution attended, other information including major, field of study, degrees, awards received, and participation in

officially recognized activities/sports.
