Course Description: A survey of the social, political, economical, cultural, religious and intellectual history of the world from the 15th century to the present. The course examines major cultural regions of the world in Africa, the Americas, Asia, Europe, and Oceania and their global interactions over time. Themes include maritime exploration and transoceanic empires, nation/state formation and industrialization, imperialism, global conflicts and resolutions, and global economic integration. The course emphasizes the development, interaction and impact of global exchange.

Course Structure and Overview:

Exams:

The course is divided into four modules. Each module ends with an exam covering the material presented in that module. (SLO3)

Online homework activities, including SmartBook, map, and critical mission activities.
