An exploration of the foundations necessary for the master of the advanced topics of clinical practice out of the hospital

Prerequisite(s): EMSP 1501, EMSP 1164

Co-requisites: EMSP 1356, EMSP 2306, EMSP 2444, EMSP2261

Student Learning Outcomes:

1. Describe the roles and responsibilities of advanced EMS personnel within the EMS system
2. Apply concepts of pathophysiology and pharmacology to the assessment and management of emergency patients;
3. Demonstrate an understanding of how to employ effective communication with patients
4. Demonstrate ethical behaviors.
5. Demonstrate an understanding of how to interpret medical terminology in the prehospital setting
6. **Discuss the well-being of the paramedic**

Evaluation/Grading Policy:

All EMS courses have a cognitive, psychomotor, and affective grading domain. A passing grade must be achieved in all of those domains in order to pass the course. If all three domains are passed, the letter grade will be assigned based on the performance in all 3 domains. Failure of any domain below the "C" range (as determined by the section) will constitute failure of the course regardless of the grades earned in the other 2 domains. Remember, it takes an actual 75 to pass the course in all sections and domains, or you will fail the entire course. Due dates are firm and work must be completed by that date. If extenuating circumstances exist, they must be made known to the instructor before the due date if possible. If not possible the reason must be made known as soon as possible with an explanation of why prior notice was not provided.
