This syllabus serves as the documentation for all course policies and requirements, assignments, and instructor/student responsibilities.

Information relative to the delivery of the content contained in this syllabus is subject to change. Should that happen, the student will be notified.

Course Description:

This course is designed to assist dual credit students in completing and passing the TSIA2 in order to take additional dual credit courses. Included are concepts from the learning sciences to help students acquire the strategies and the tenacity necessary to succeed in English, mathematics, in other college coursework, and in their future careers. Course instruction focuses on four main content strands: developing and maintaining motivation for college success and developing and using strategies and skills. Three hours credit.

Prerequisite(s): none.

Student Learning Outcomes:

1. Identify and use strategies to increase learning, motivation, memory, test-taking abilities, note-taking abilities, and study skills.
2. Assist others in building strategies to increase learning and academic success
3. Build a basic understanding of quantitative reasoning, algebra, geometry, and data analysis.
4. Build a basic understanding of reading comprehension, literary text analysis, and grammar conventions.
5. Demonstrate knowledge of basic essay writing.

Evaluation/Grading Policy:

Course Requirements:

A breakdown of course requirements and assignments are as follows:

Participation (10%):

All students will be required to upload their Pre-Assessment Activity (PAA) certificate and TSIA2 ELAR and Math score sheets

Quizzes and Discussion Posts (35%):

Students will be required to complete reading and “Mini TSI” quizzes every week (with exceptions for weeks dedicated to the completion of practice tests and taking the TSIA2) to evaluate skills learned in the assigned readings. Students are permitted to take these quizzes a second time for a chance to improve their grade *before the posted due date*.

Throughout the semester, discussion boards will be assigned. These will involve tasks such as creating a study strategy, drafting thesis statements, and explaining math processes. Please review individual

discussion posts for instructions.

Practice Test Reflections (40%)

At the beginning of module two and three, students will take the practice test provided on Accuplacer's website. After finishing the practice test, students will take a screenshot of their score report and upload it with their reflection. Reflections are 500 words and respond to the questions provided in the assignment prompt.

At the end of module two and three—the week before taking the TSIA2 for each subject—students will take the practice test a second time. They will once again upload a score report and a 500 word reflection responding to the assignment prompt.

There will be a total of four reflections, each being 10% of a student's overall grade.

Practice TSIA2 Essay (10%)

Students will plan and write a multi-paragraph essay (300–600 words) in which they develop their point of view to an assigned prompt. Essay will be graded on a scale of 1-8 based on TSIA2 standards and guidelines. This is done to provide the student with sufficient practice for the actual TSIA2 essay.

Syllabus Acknowledgement and Course Evaluation (5%)

Students will submit a syllabus acknowledgement at the beginning of the semester agreeing to the terms of this syllabus. Students will submit a course evaluation at the end of the semester.

Late Work Policy:

Weekly work such as quizzes and discussion posts will not be accepted late. Major assignments such as practice test reflections and the practice essay may be turned in late, but will receive 5 points off per day late.

Required Instructional Materials:

No textbook is required for this course; all readings and course materials are provided within Blackboard.

Minimum Technology Requirements:

Students must have daily access to a computer and broadband internet service to take this course. The computer should have Windows 8 or later, or Mac OS 12 or higher.

It is recommended that you use Google Chrome or Firefox as a browser with the Blackboard LMS (learning management system). To hear the video presentations properly, a speaker system, either within the computer or externally, is required.

This is a completely online course; therefore, success requires daily login. If a student does not have access to a personal computer with the minimum computer requirements, he/she should research computer access options in the local community, college computer lab, etc., before enrolling in this course.

Required Computer Literacy Skills:

In order to be successful in this course, students should minimally possess the following technical skills:

1. The ability to properly use email and check important course notifications

2. The ability to properly update personal computer settings
3. The ability to use a word-processing application
4. The ability to properly connect to and navigate the internet
5. The ability to navigate Blackboard and submit files within it
6. The ability to take screenshots and save files

Course Structure and Overview:

This is a 16-week online course designed to prepare students for the TSIA2. The course is divided into three modules: General Skills, Reading and Writing, and Mathematics. This course will provide students with proven learning and study skill strategies that will promote academic success.

Students are expected to complete assigned readings, videos, quizzes, and written assignments by their due dates. To be successful, it is very important for students to keep up with course materials and assignments.

Communications:

The college's official means of communication is via your campus email address. Your instructors will use your campus email and Blackboard to communicate with you outside of class. Make sure you keep your campus email cleaned out and below the limit so you can receive important messages.

Alternate Operations During Campus Closure and/or Alternate Course Delivery Requirements:

In the event of an emergency or announced campus closure due to a natural disaster or pandemic, it may be necessary for Northeast Texas Community College to move to altered operations. Week 4 (Sept. 14) – Module 2, Reading and Writing

- Take practice test and write reflection by end of the week

Week 5 (Sept. 21)

- Watch “TSI Practice Test Training – Introduction to TSI Reading,” “Author’s Purpose and Tone,” “Vocabulary in Context,” and read “Phrasing and Key Words” in Blackboard. Reading quiz, Key Words matching quiz, and TSI mini quiz due by end of week.

Week 6 (Sept. 28)

- Watch “TSI Practice Test Training – Grammar & Sentence Structure” and “Comma Story – TED Ed” and read “Editing Focus: Sentence Structure” and “Editing Focus: Subject-Verb Agreement.” Reading quiz and TSI mini quiz due by end of week.

Week 7 (Oct. 5)

- Read “Basic Essay Structure,” “Example TSIA2 Essays,” and “Transitional Devices.” Reading quiz due by end of week
- Review “Thesis Tips” in Blackboard. Submit your thesis to the discussion board by Friday and respond to a peer by Sunday

Week 8 (Oct. 12)

- Write practice TSI Essay by Wednesday
- Take practice test and write reflection by end of week

Week 9 (Oct. 19)

- You have this week to take the Reading and Writing TSI. Upload your score report by the end of the week

Week 10 (Oct. 26) – Module 3, Mathematics

- Take practice test and write reflection by end of week

Week 11 (Nov. 2)

- Read “Introduction to Whole Numbers – OpenStax,” and watch “Practice Test Training – Introduction to TSI Math,” “Numbers and Operations,” “Word Problem Strategies,” “Fractions: When to Multiply or Multiply Across.” Reading quiz and TSI mini quiz due by end of week
- Process Explanation discussion board due by end of week – submit Friday, respond to peer by Sunday

Week 12 (Nov. 9)

- Watch “Algebra Linear Equations Guide,” “Geometry and Measurement,” and “Expressions and Polynomials Guide” and read “Use Multiplication Properties of Exponents – OpenStax,” “Quadratic Equations – OpenStax,” and “Additional Terms.” Reading quiz and TSI mini quiz due by end of week.
- Process Explanation discussion board due by end of week – submit Friday, respond to peer by Sunday

Week 13 (Nov. 16)

- Read “What are the Odds? – OpenStax” and watch “TSI Practice – Probability Strategies,” “Math Antics – Mean, Median, and Mode,” “Introduction to Statistics,”

“Categorical Displays: Bar Graph, Pareto Chart, and Pictogram,” and “Find the Sample Size and Percent of Sample from a Bar Graph.” Reading quiz and TSI mini quiz due by end of week

- Process Explanation discussion board due by end of week – submit Friday, respond to peer by Sunday

Week 14 (Nov. 23)

Thanksgiving break – no assignments

Week 15 (Nov. 30)

- Take practice test and write reflection by end of week

Week 16 (Dec. 7)

- You have this week to take the Math TSI. Upload your score report by the end of the week
