This syllabus serves as the documentation for all course policies and requirements, assignments, and instructor/student responsibilities.

Course Description:

The application of common algebraic functions, including polynomials, exponential, logarithmic, and rational, to problems in business, economics, and the social sciences are addressed. The applications include mathematics of finance, including simple and compound interest and annuities; systems of linear equations; matrices; linear programming; and probability, including expected value. Three hours credit.

1324.4 Demonstrate fundamental probability techniques and application of those techniques, including expected value, to solve problems.

1324.5 Apply matrix skills and probability analyses to model applications to solve real-world problems.

A series of online homework assignments via OHM Lumen in Blackboard (Bb) are 40% of your final grade, and the Midterm Exam (20%) and Final Exam (30%) will contribute to 50% of the final grade. Chapter Quizzes will count for 10% of your final grade.

Students are required to have access to a computer with high-speed internet, a microphone, a webcam, and appropriate system rights to download and install the necessary software. Please note, the college does not provide this equipment.

Two exams will be given, a midterm and a final, which together will count for 50% of your total grade. If an exam is missed or failed, the highest possible make-up grade is a 70 (with instructor notification prior to the exam missed).

The Final Exam must be proctored. You have 3 choices for proctoring:

- 1) **Take your Final Exam at NTCC's Testing Center (free). They are open from 8:00-6:00 Monday – Thursday.**
- 2) **Take your exam with an approved proctor at another testing center (usually a cost involved).**
- 3) **Take your exam at home and use Microsoft TEAMS to record you taking the exam. The TEAMS Proctoring Instructions can be found in Blackboard, as well as the Proctor Form you would need to get approved by me about a week PRIOR to the Final Exam. For TEAMS, students are required to have access to a computer with high-speed internet, a microphone, a webcam, and appropriate system rights to download and install the necessary software. Please note, the college does not provide this equipment.**

****If an exam is not proctored appropriately, a grade of zero will be given.**

Lumen OHM homework will require the use of “Late Passes” if not completed by the scheduled due date. Each student has 255 last passes that extend the assignment due date for 48 hours. Students may use more than one late pass per assignment that is past due.

If you have trouble with any of the activities working properly, you might change your web browser as your first solution. The Default Browser in Windows 10 is Edge. This browser does not do well with Blackboard! If you go to Windows Accessories, you will find Internet Explorer still on your computer but is not your default browser. If you have any difficulties navigating with Edge, close it and go to Internet Explorer.

To use TEAMS, you must have access to a computer with high-speed internet, a microphone, a Webcam, and appropriate systems rights to download any necessary software. Please note, the college does not provide this equipment.

Course Structure and Overview:

This is an 8-week online course where students are required to access graded activities on the Blackboard Learning Management System. A typical class involves general participation by all members in discussions regarding mathematical principles and procedures being studied. Students are required to complete online homework and online exams. It is particularly important for students to keep up with course materials and assignments since this is a very fast-paced course. Students are expected to watch instructional videos, read course textbooks, and complete online assignments located in the Learning Management System, Blackboard, by due dates.

Communications:

Emails, TEAMS and phone messages will be responded to within 24 hours. If you do not receive a response within 24 hours, then the email or phone message was not received. Students are expected to abide by Netiquette rules when communicating online. See this link for details: [Netiquette Rules](#).

The college's official means of communication is via your campus email address. I will use your campus email address, Blackboard, and Microsoft TEAMS to communicate with you outside of class. Make sure you keep your campus email cleaned out and below the limit so you can receive important messages.
