4 credit hours.

Advanced topics involving welding of pipe using the shielded metal arc welding (SMAW) process. Topics include electrode selection, equipment setup, and safe shop practices. Emphasis on weld positions 5G and 6G using various electrodes.

Prerequisite(s): WLDG 1435 or consent of instructor.

Course Structure and Overview:

A checklist of required tests/tasks will be provided for each student the first day of class. Safety will be monitored daily by all instructors to ensure all shop rules are being followed.

General Safety Policies

Anyone with extremely long hair must have some way to keep it up (hair net, hat). There will be no open-toe shoes worn in the shop (sandals, flip flops). Each student will be required to have a pair of safety glasses to be always worn.

Student Responsibilities/Expectations:

It is important to present a professional image in the workplace. Therefore, students are required to wear 100% cotton long sleeve shirts. They may be purchased in the bookstore, or you can purchase in town. If your employer furnishes uniform shirts, they may be worn in place of the school shirt. These shirts should always be

clean and neat. You must have approved welding clothing by the second week of class. If you do not, you will not be allowed to start any hands-on welding in the lab until you comply with the welding shop's dress code. Shorts and sandals are not allowed. Professional appearance is part of your grade.
