# This syllabus serves as the documentation for all course policies and requirements, assignments, and instructor/student responsibilities.

**Course Description:** Topics address recently identified current events, skills, knowledges, and/or attitudes and behaviors pertinent to the technology or occupation and relevant to the professional development of the student. **Prerequisite(s):** Cosmetology Certificate Program (32 CH in CSME Courses)
