Course Title: Basic Metal Repair

Course Credit Hours: 3 Lecture Hours 2 Lab Hours 3

Textbook: Collision Repair and Refinishing Second Edition (Thomas/Jund)

Supplies: Spiral notebook and pen.

Course Description: Covers metal principles and working techniques including proper tool usage and product application.

End-of-Course Outcomes: Perform basic metal straightening procedures; utilize basic body shop hand tools and plastic filler application techniques; and apply personal and environmental safety practices.

Course Requirements: Students must do the following:

1. *Attend class regularly and on time.*
2. *Demonstrate knowledge of all learning objectives and competencies.*

4. *Complete all exams and coursework.*

Course Format: The course will be presented with lectures including text and technique. A majority of the instruction will be in the lab with hands on experience.
