Course Description: (3 Semester Hours)

The course provides the student with foundational information about the U.S. legal system and dispute resolution, and their impact on business. The major content areas will include general principles of law, the relationship of business and the U.S. Constitution, state and federal legal systems, the relationship between law and ethics, contracts, sales, torts, agency law, intellectual property, and business law in the global context.

- Describe the origins and structure of the U.S. legal system.
- Describe the relationship of ethics and law in business.
- Define relevant legal terms in business.
- Explain basic principles of law that apply to business and business transactions.

- Describe current law, rules, and regulations related to settling business disputes.

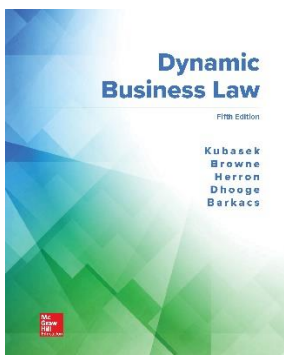

All online courses require extensive engagement (with other students, the instructor, and the course materials) as well as timely completion of assignments. Late work is not allowed in this course, so you must plan your schedule carefully. Although attendance is not the same as a face-to-face course you must “attend” regularly online in order to complete all of the assignments and meet required due dates.

Course Structure and Overview:

This is an online summer course and will require extensive engagement (with other students, the instructor, and the course materials) as well as timely completion of assignments. Assignments are due weekly thus, keeping up with the schedule is essential to your success. Your personal schedule must allow you to keep up with the due dates for the readings and other assignments. Late work is not allowed in this course, so you must plan your schedule carefully. The following items reflect your grade criteria:

Smartbook Reading Assignments in Connect:

The Smartbook chapter assignments are to be completed in Connect and are worth 10% of your overall course grade. These assignments are timed and your score will be released immediately. There is a link in BB for each Smartbook assignment. When you click on that link, the Smartbook assignment will launch automatically. These assignments can be submitted for credit no later than the assigned due date at midnight. **No late work will be accepted as the answers will be released to you immediately following the due date.** See course schedule below for specifics.

Chapter Assignments in Connect:

The chapter assignments are to be completed in Connect and are worth 30% of your overall course grade. Please see each chapter’s material in BB for each specific assignment and a link to the Connect work. These assignments can be submitted for credit no later than the assigned due date at midnight. **No late**

work will be accepted as the answers will be released to you immediately following the due date. See course schedule below for specifics.

Quizzes in Connect:

Each chapter will have an associated quiz in Connect. These quizzes will count as 30% of your overall course grade. All quizzes consist of 25 multiple choice questions and are worth 100 points. You will have 45 minutes to complete them and only 1 attempt. Please see the course schedule attached to this syllabus for dates.

Case Studies in BB:

You will be required to complete 2 case studies during this course. These cases are hypothetical scenarios that reflect your course material. Each case study includes questions that you should answer in short essay format. Student submissions should be made via the appropriate link in BB. A grading rubric is attached at the end of this syllabus. These case studies make up 30% of your overall course grade.

Late Work Policy:

Please allow yourself an appropriate amount of time to complete the coursework. Students who wait until the last minute often miss the deadline and then cannot receive credit for their work. All due dates for the entire course are included with this syllabus so you can work as far ahead as you would like. Please understand that I must adhere to this policy for all students so exceptions will not be made.

Final Grades:

Your final course grade will be based upon the grade scale noted earlier in this syllabus. THERE ARE NO extra credit opportunities. In addition, there are no “retakes” for any assignments or exams. The scores that you receive on your original submissions will be what is counted toward your final grade. Please understand that I must adhere to this grading policy for all students so exceptions will not be made.
