This syllabus serves as the documentation for all course policies and requirements, assignments, and instructor/student responsibilities.

Course Description: In-depth study and applications of trigonometry including definitions, identities, inverse functions, solutions of equations, graphing, and solving triangles. Additional topics such as vectors, polar coordinates and parametric equations may be helpful. Three hours credit.

Prerequisite(s): MATH 1314 or its equivalent or an appropriate placement score

- 1316.1 Compute the values of trigonometric functions for key angles in all quadrants of the unit circle measured in both degrees and radians.
- 1316.2 Graph trigonometric functions and their transformations.
- 1316.3 Prove trigonometric identities.
- 1316.4 Solve trigonometric equations.
- 1316.5 Solve right and oblique triangles.
- 1316.6 Use the concepts of trigonometry to solve applications.

Core Curriculum Purpose and Objectives:

Through the core curriculum, students will gain a foundation of knowledge of human cultures and the physical and natural world; develop principles of personal and social responsibility for living in a diverse world; and advance intellectual and practical skills that are essential for all learning.

Courses in the foundation area of mathematics focus on quantitative literacy in logic, patterns, and

relationships. In addition, these courses involve the understanding of key mathematical concepts and the application of appropriate quantitative tools to everyday experience.
