Course Description: This course is the study of the sun and other bodies in our solar system, including the origin of our solar system. Three hours college credit.

Evaluation/Grading Policy:

We will be using the Starry Night curriculum this semester. You will find a link in the class Blackboard that take you to the website where you will complete your assignments. NOTE: ALL REGULAR ASSIGNMENTS WILL BE COMPLETED THROUGH STARRY NIGHT, NOT BLACKBOARD. Reading Quizzes in Starry Night will represent 20% of your grade and Exercises in Starry Night will count 30%.
