## **Course Description:**

3 credit hours. Lecture/Lab/Clinical: Three hours of lecture each week.

This course is an introduction to the fundamental principles of behavior. Special emphasis is placed on methods of research and critical thinking skills. This is a survey course and covers a variety of topics, theories and approaches to the scientific study of behavior and mental processes. PSYC 2301 is reading and writing intensive and is a college sophomore course.

Upon successful completion of this course, students will:

- 1. Identify various research methods and their characteristics used in the scientific study of psychology.
- 2. Describe the historical influences and early schools of thought that shaped the field of psychology.
- 3. Describe some of the prominent perspectives and approaches used in the study of psychology.
- 4. Use terminology unique to the study of psychology.
- 5. Describe accepted approaches and standards in psychological assessment and evaluation.
- 6. Identify factors in physiological and psychological processes involved in human behavior.

**Minimum Technology Requirements:** Students must have access to a computer with Windows XP SP3 or later OR MAC OS X10.3 or higher. **Course Structure and Overview:** Students will complete online assignments and quizzes (MindTap) for each chapter, two SLO quizzes in class (one covering Ch. 2, the other comprehensive), 4 multiple-choice exams, an Experimental Design, 2 Summary Papers (summarizing select research articles), a visit to the Hospitality House, and a reaction paper to the HH visit. Self-Improvement opportunities and extra credit options are available throughout the semester to help students improve their overall grade in the course.

**Communications:** Students can expect my reply to any email correspondence within 12-24 hours, typically within a couple hours. \*Reminder: NTCC email is the official form of communication used by the college.
