# This syllabus serves as the documentation for all course policies and requirements, assignments, and instructor/student responsibilities.

### **Course Description:** 3 credit hours.

Understanding music through the study of cultural periods, major composers, and musical elements. Illustrated with audio recordings and live performances. (Does not apply to a music major degree.)

This course will expose you to the creative endeavors of the human imagination and to the prominent ideas and issues that have shaped the course and character of the world's cultures. Throughout this semester, we will be focusing on key works of art, literature, and music from prehistory to the present exploring the key ideas, issues, and styles that have dominated and shaped the world's cultures. Earn up to 6 hours college credit for HUMA 1301 and MUSI 1306. Even if only enrolled in one of those section, students need to come on both Monday and Wednesday as the course materials are intertwined. Students will get the same grade for both courses as a result.
