Course Description: Study of the use and abuse of drugs in today's society. Emphasizes the physiological, sociological, and psychological factors.

Prerequisite(s): None

- Understand the different types of drugs, chemical makeup, and side effects.
- Describe the historical sequence of controls on opioids, cocaine, marijuana, and other controlled substances.
- List specific strategies used to reduce harms associated with illegal drugs.

Grading and evaluation--In general, a course grade of a "C" represents an acceptable level of work. A course grade of "B" represents a substantial effort and achievement. This browser does not do well with Blackboard! If you will go to Windows Accessories you will find Internet Explorer still on your computer, but is not your default browser. If you have any difficulties navigating with Edge, close it and go to Internet Explorer. You can download Blackboard Student for your smart phone from the Play store or the App store. Course Structure and Overview:

Course Structure and Overview: This is a sixteen-week online course where students are required to access graded activities on the Blackboard Learning Management System. A typical class involves general participation by all members in discussions. Students are required to complete online homework, discussion forums, assignments and exams. Students are expected to watch instructional videos, read course textbook, and complete online assignments located in the Learning Management System, Blackboard by due dates.

Assignments:

All written assignments should be typed (12-point font), double-spaced, with one-inch margins, a title page and stapled. Students are encouraged to submit written work that has been spell-checked and is free of grammatical errors. Students are expected to use APA style when citing reference materials. Please refer to the APA manual or use www.apastyle.org for guidelines on writing in APA format. Students are advised that points will be deducted if these criteria are not met.

Discussions/Activities

Due Date: Varies

Grading: 100 points

Discussions/Activities is where we will assess your participation whether you are an online or face-to-face learner. You are expected to be an active and engaged class member throughout the semester.

Discussions/Activities are the way to exchange ideas and learn from your peers. Each student is expected to participate fully in the discussions/activities. It could involve summarizing articles, responding to questions from the text, or viewing and commenting on streaming videos.

Online Learners Only

To receive credit, you must post your response to the discussion board questions by Thursday at midnight. In addition, you must post a response to another peer's post by Sunday at midnight.

Your grade on the discussion board is based on participation. Each discussion board assignment is worth 10 points. However, to receive full credit for these posts, you must fulfill some basic requirements: - After posting your answer to the question, you are expected to respond to a minimum of one other peer in the class. Initial posts should be a minimum of 75 words and responses at a minimum of 50 words. All posts should be relevant to the topic being discussed but should also attempt to introduce a new point of view or piece of information or otherwise further the discussion. Posts should use correct grammar, punctuation, and vocabulary appropriate for a college-level course. Misuse of the discussion boards will not be accepted.

Two Activities will cover the following learning outcomes:

- The ability to Identify the various methodological approaches to the collection and analysis of data in sociology through journal articles.
- The student's ability to describe key concepts in sociology through reflection on sociology activities.

Drug Abuse Prevention Multimedia Presentation Assignment

Due Date: November 1st

Grading: 100 points

As a culminating project, the student will incorporate the knowledge gained in the class into an 8-10 -slide presentation, focusing on a specific drug of choice and how it impacts society. The presentation aims to provide general information about the drug and then focus on preventive solutions to abuse. This assignment must reference at least one scholarly reference in the current APA format.

Global Project

The student will identify one country and do a comparative report on the drug abuse and abuse within that country. Your primary task will be to describe recent substance use trends in your country and the trends within that society. The laws of use, prevention methods, and solutions implored to alleviate use. The outline is provided in Blackboard.

Communications:
