Course Title: Vehicle Trim and Hardware

Course Credit Hours: 3 **Lecture Hours** 2 **Lab Hours** 3

Textbook: Collision Repair and Refinishing Second Edition (Thomas/Jund)

Supplies: Spiral notebook and pen.

Course Description: Advanced course in color theory, analysis, tinting, and blending techniques for acceptable paint matching.

Course Learning Objectives: Analyze dimensions of color and theory; tint automotive paints; blend paint using proper spray gun techniques; and perform final detailing procedures.

Course Requirements: Students must do the following:

1. *Attend class regularly and on time.*
2. *Demonstrate knowledge of all learning objectives and competencies.*
3. *Take responsibility for learning process.*
4. *Complete all exams and coursework.*

Course Format: The course will be presented with lectures including text and technique. A majority of the instruction will be in the lab with hands on experience.

Method of Evaluation: Students will be evaluated on their mastery of course competencies, the number of competency hours completed, attendance and test performance.
