**Course Description:** A survey of the social, political, economical, cultural, religious and intellectual history of the world from the 15th century to the present. The course examines major cultural regions of the world in Africa, the Americas, Asia, Europe, and Oceania and their global interactions over time. Themes include maritime exploration and transoceanic empires, nation/state formation and industrialization, imperialism, global conflicts and resolutions, and global economic integration. The course emphasizes the development, interaction and impact of global exchange.

#### ***Exams:***

Students will write an essay on a topic related to the course. Specific details and requirements can be found in the “History Essay” link in Blackboard. (SLO1)

#### ***Attendance and Participation:***

Online homework activities, including SmartBook, map, and critical mission activities.
