Course Description: A survey of the social, political, economic, cultural, and intellectual history of the United States from the pre-Columbian era to the Civil War/Reconstruction period. United States History I includes the study of pre-Columbian, colonial, revolutionary, early national, slavery and sectionalism, and the Civil War era. Themes that may be addressed in United States History I include: American settlement and diversity, American culture, religion, civil and human rights, technological change, economic change, immigration and migration, and creation of the federal government.

Course Structure and Overview:

MidTerm Exam:

MidTerm examination will cover material from the first half of the course.

Final Exam:

The final exam will focus on material covered in the second half of the course, but will also include some questions that are comprehensive in nature.

History Research Project:

Students will conduct research and write an essay on a topic related to the course.

Connect Based Assignments:

Online activities that are auto-graded. These include chapter reading, map activities, and podcasts. Point values are weighted so keep in mind that some activities are worth more points than others. These activities are intended to help prepare you for the MidTerm and Final Exams.

Discussion Based Assignments

These assignments involve writing and are manually graded involving a rubric. These activities allow you to be creative as well as develop critical thinking skills. Topics range from Revolutionary Role Playing to using primary sources to tell your own life story and including analyzing early American political cartoons.

Communications: Blackboard messages or direct email serve as the best ways to communicate. *Reminder: NTCC email is the official form of communication used by the college. TEAMS is the only other official form of communication.
