Course Structure and Overview:

This course is presented online using Blackboard Learning Management System. Students will be required to access Blackboard for all assignments. The course utilizes writing assignments as presented by the course textbook, and additional on-line instructional and project based components.

Significant grade reductions will occur when a student submits a previous semester's work.
