Evaluation/Grading Policy: The online assignments are split between HUMA 1301 and MUSI 1306. See Blackboard for the online components. The Midterm and Final exams will cover the material in the course(s) in which you are enrolled. You only need to complete the online activities for the course(s) in which you are enrolled. The live performance final, artistic reaction pieces, and research project with poster are required regardless of whether you are enrolled in only one course or both courses. You will need to attend two artistic functions, whether you are enrolled in one course or both.
