Course Description:

3 credit hours. Lecture/Lab/Clinical: Two hours of lecture and four hours of lab each week. Prerequisite(s): <u>EMSP 1164</u>, <u>EMSP 1501</u> Co-requisite(s): <u>EMSP 1338</u>, <u>EMSP 1356</u>, <u>EMSP 2330</u>

A comprehensive course covering all aspects of the utilization of medications in treating emergency situations. Course is designed to complement Cardiology, Special Populations, and Medical Emergency courses.

Student Learning Outcomes:

- 1. Categorize the classification of drugs.
- 2. Calculate Drug Dosages
- 3. Identify the therapeutic use, routes of administration, indications, contraindications, and adverse effects.
