This syllabus serves as the documentation for all course policies and requirements, assignments, and instructor/student responsibilities.

Course Description: MATH 0304 surveys a variety of mathematical topics needed to prepare students for a gateway college-level mathematics course. Topics include: numeracy with an emphasis on estimation and fluency with large numbers; evaluating expressions and formulas; rates, ratios, and proportions; percentages; solving equations; linear models; data interpretations including graphs and tables; verbal, algebraic and graphical representations of functions; exponential models. No college credit.

Prerequisite(s): TSI Incomplete Status with Multiple Measures Placement on TSI Placement Chart

Corequisite(s): 1) EDUC 1100 2) MATH 0100 if TSI Incomplete Status with Multiple Measures Placement as posted on TSI Placement Chart is required.

0304.1 Use appropriate symbolic notation and vocabulary to communicate, interpret, and explain mathematical concepts.

0304.2 Define, represent, and perform operations on real numbers, applying numeric reasoning to investigate and describe quantitative relationships and solve real world problems in a variety of contexts.

0304.3 Use algebraic reasoning to solve problems that require ratios, rates, percentages, and proportions in a variety of contexts using multiple representations.

0304.4 Apply algebraic reasoning to manipulate expressions and equations to solve real world problems.

0304.5 Use graphs, tables, and technology to analyze, interpret, and compare data sets.

0304.6 Construct and use mathematical models in verbal, algebraic, graphical, and tabular form to solve problems from a variety of contexts and to make predictions and decisions.

Evaluation/Grading Policy:

The grade for this course will be based on the following:

1. Homework –Practice homework must be completed on time. Homework grades will include MyMathLab homework assignments. These will all average together to count for 40% of your final course grade. Note that homework is completed online through MyMathLab. **No late work will be accepted.**
2. Exams will count as 50% of your final course grade. A Midterm Exam and a Final Exam will be given this semester. **No make up tests are allowed,** however the Final Exam grade can replace a missing or low test grade.
3. Final Exam – A comprehensive final exam is mandatory for all students.
4. In person attendance is required.

Course Structure and Overview: :

This is a 8-week face-to-face course that meets parallel to the co-requisite course Learning Frameworks (EDUC 1300). A typical class involves general participation by all students in discussions and working problems that involve the analytical skills needed to apply the mathematical and statistical principles taught in MATH 0304. Students are required to complete online homework in addition to quizzes, and over the course of the semester, a midterm exam and a final exam. It is very important students attend class and fully participate in the learning activities and assignments. An attendance grade will be issued.

Communications:

Emails will be responded to within 24 hours during the week and 48 hours on the weekend. The college's official means of communication is via your campus email address. Your instructors will use your campus email and Blackboard to communicate with you outside of class. Make sure you keep your campus email cleaned out and below the limit so you can receive important messages.

Institutional/Course Policy:

Students are expected to attend all classes to be successful in MATH 0304. Students seeking to withdrawal from the course will be directed to the appropriate student services or academic advisor.

While in class, you are expected to pay attention and be present in class. Being present looks like:
