#### **Course Description:** 3 credit hours.

Lecture/Lab/Clinical: Three hours of class each week.

Origin and development of the U.S. Constitution, structure and powers of the national government including the legislative, executive, and judicial branches, federalism, political participation, the national election process, public policy, civil liberties and civil rights.

- 5. Evaluate the role of public opinion, interest groups, and political parties in the political system.
- 6. Analyze the election process.
- 7. Describe the rights and responsibilities of citizens.
- 8. Analyze issues and policies in U.S. politics.

The highest score of each quiz will be averaged to make up 10% of your final grade. You will not receive the same questions each time you take the quiz. The questions are randomized.

#### Communication Activities:

Written and/or oral communication. Involves introductions, sharing of at least three relevant articles with the class, coming up with a bill proposal, and up to three government essays.

**Communications:** Emails will be answered within 24 hours. NTCC email is the official form of communication used by the college.
